RULES:

- CREATE A NEW, ORIGINAL, FAMILY FRIENDLY, SHORT HORROR GENRE SHORT FILM INSPIRED BY COSPLAY CULTURE. DUE 10PM AUGUST 1ST, 2014.
- MANDATORY PROP: A STOCKTONCON AUGUST 2014 FLYER MUST BE VISIBLE SOME WHERE IN YOUR FILM. VISIT SACHORRORFILMFEST.COM FOR THE FILE DOWNLOAD.
- YOUR FILM CAN BE NO LONGER THAN 5 MINUTES IN LENGTH.
- YOUR FILM MUST BE FAMILY FRIENDLY. THINK MPAA G AND PG RATINGS.
- MANDATORY LINE OF DIALOGUE.

Additional Rules...

- PG-13 to XXX pornographic material will not be accepted. Films will be screened by judges to ensure they meet the family film guideline. If it is not family friendly... IT WILL NOT PLAY.
- 5 minute time limit. No time minimum. Time includes credit roll.
- Use royalty free music or music you are licensed/permitted to use.
- NTSC format. No PAL.
- All entrants agree to grant the Sacramento Horror Film Festival non-exclusive rights for their films to appear on festival promotional videos promotions for the Sacramento Horror Film Festival 2014 and beyond.
- Films may not be screened publicly prior to August 9th, 2014.
- "Official Selection of the 2014 Stocktoncon & Sacramento Horror Film Festival Filmmaker Challenge" must be present in your credits.
- Must be 18 years of age or older to enter. If you are under 18 then a parent or guardian must sign for you.
- **\$0 Entry FEE. That's right. No entry fee! FILMS DUE by 10PM 8/1/14.**
- If accepted, we will need a copy of your film in one of the digital formats. High resolution quicktime, avi, mp4, .mov.
- Online film links/passwords must be RECEIVED by August 1st, 2014.
- If your film is in a foreign language it must have subtitles in English.
